- 1. Possess current PCANCAS Level 1 Coaching or EA NCAS equivalent.
- 2. Be on the current C Examiner's List.
- 3. Be currently coaching at a Pony Club affiliated with Pony Club WA.
- 4. Have a minimum of three year's teaching at C* or K Efficiency Level or above.
- 5. Have successfully produced at least three groups of C* or K Efficiency Certificate Candidates.
- 6. Have a strong commitment to the Pony Club Movement.
- 7. Have attended Coaching Schools and Examiners' Seminars at C* level or above.

C* / K Examiners must serve a probationary period of two tests, with a recommended minimum of three candidates per test for C* or minimum 3 Individual candidates for K. All Examinations must be conducted under supervision of a current C* / K Examiner.

C*/K Examiners are nominated by a meeting of the Zone Coaching Panel, through their Zone Committee, approved by the Pony Club WA State Coaching Panel and are ratified by Pony Club WA Board of Directors.

Fees for C* / K Examiners are fixed by the Pony Club WA Board and reviewed from time to time.
