# Amendments to the 2022 Eventing Rules (revised 10 May 2022)

# Page 13:

**13** Age of Rider. Wording updated to be consistent with other disciplines.

Old wording: "From the beginning of the calendar year in which the rider turns 14" Updated wording: "Age as at 1 January of the calendar year – 13 years"

#### **14 Qualification of Horse & Rider Combination:** *Introduction of MER (Minimum Eligibility Requirements)* **14.1 Upgrading**

A PC 95, PC105 Rider Categorization, including Open classes.

If a rider has 15 MER's (Minimum Eligibility Requirements) at a level, or higher level, over a rolling 8-year period then this deems the rider to be categorised at that level.

# 14.1.2 Minimum Eligibility Requirements

All results must be as a combination unless the rider is categorised at the level they are entering. Refer to rule EA 519.1

• For a horse and rider to start in PC 115 they must have 3 qualifying results in PC 105 or official CCN1\*. Results must be as a combination for Junior riders - if established/categorised exemption by application may be considered. One of these results may not have more than 20 Cross Country jumping faults. The other 2 must be clear of Cross Country jump faults.

• A rider who is established/categorised, as per EA National Rules, to ride at CC4\* level, may enter a horse at PC115 level competitions without the horse having any previous qualifying results.

• For a horse and rider to start in PC 105 they must have 3 qualifying results in PC 95 or official EvA95. Results must be as a combination for Junior riders - if established/categorised exemption by application may be considered. One of these results may not have more than 20 Cross Country jumping faults. The other 2 must be clear of Cross Country jump faults.

• A rider who is established/categorised, as per EA National Rules, to ride at CC3\* level, may enter a horse at PC105 level competitions without the horse having any previous qualifying results.

• For a horse and rider to start in PC 95 they must have 2 qualifying results in PC 80 or official EvA80. Results must be as a combination for Junior riders. One of these results may not have more than 20 Cross Country jumping faults. The other 1 must be clear of Cross Country jump faults.

• A rider who is established/categorised, as per EA National Rules, to ride at CC2\* level, may enter a horse at PC95\* level competitions without the horse having any previous qualifying results.
