The Pony Club is an international youth organisation dedicated to providing opportunities for young people that are interested in horses, ponies and riding. Pony Clubs exist to promote the holistic development of young people by encouraging sportsmanship and good citizenship. Through pony club, opportunities are provided to young riders to gain knowledge and become proficient in their chosen equestrian sport.

The Pony Club movement started in the United Kingdom in 1929 with the stated aim of encouraging young people to learn to ride and enjoy all kinds of sport connected with horses and riding.

The first Pony Club in Western Australia was established in 1959. Pony Club Western Australia (Pony Club WA) is the recognised state sporting organisation representing the interests of 12 zones, 55 clubs and over 3311 members.

Chairperson's Report

I'm pleased to present the Chair Report for the 2024 Annual General Meeting. This year has been a testament to the dedication, and unwavering spirit of our Pony Club community.

We began 2024 facing an unexpected challenge: the extreme heat experienced across Western Australia. This presented significant obstacles, leading to the cancellation of the State Coaching School and club rallies. Clubs and coaches were forced to adapt quickly, demonstrating amazing creativity in adjusting their programs and ensuring the continuity of our activities. This period highlighted the strength and adaptability of our members and committees, who did an amazing job at overcoming the challenges.



Despite these initial hurdles, our riders achieved great success on both the national and international stage. We were proud to witness the outstanding performances of Isabelle Cox, Emma Wiese, Daniel Wiese, and Campbell Black at the Pony Club International Alliance Tetrathlon in Ireland. Under the guidance of Coach Nikita Mawhirt, they represented Western Australia with excellence, showcasing their talent and dedication to our sport.

Closer to home, Lauren Bassola from Swan Valley Horse & Pony Club earned the prestigious honour of representing Australia at the PCIA National Mounted Games in Canada. Our state teams also excelled at the national championships in Victoria. The senior team took home first place, and the junior team secured a commendable second place, highlighting the high calibre of riders we have within our state.

The introduction of the PCIA Virtual Dressage provided an exciting new avenue for our dressage riders to showcase their skills. We witnessed numerous individual and team successes, further demonstrating the talent within Pony Club WA.

Our partnership with the Royal Agricultural Society for Pony Club Day at the Perth Royal Show was a highlight of the year, providing a platform for our members to excel in Showman, Showjumping, and Games. The event was a resounding success, showcasing the skill of our riders.

The State Coaching School, held in late November/early December, embraced technology to support our country coaches through online presentations. This innovative approach enhanced the accessibility and effectiveness of our coaching programs, ensuring that our coaches are equipped with the latest knowledge and skills.

In addition to the State Coaching School, the panel were able to secure a Regional Servicing Grant, allowing them to coordinate and facilitate training sessions and workshops throughout regional WA. We had over 140 participants attend the various workshops.

We extend our sincere gratitude to Thompson & Redwood for their continued and invaluable support. Their sponsorship of the T&R Pony Mount of the Month program, which builds confidence in our younger riders, and the introduction of the “Spirit of Pony Club” category has had a great impact on our community.

The High Performance 2-day Camp hosted by Serpentine Pony Club provided an excellent opportunity for over 60 aspiring riders to refine their skills and advance their performance.

We wrapped up the year with the Awards Night, held in December, where we celebrated the achievements of our members, coaches, and volunteers. Over 250 people attended and shared a meal under the festoon lights and marquee. The evening took place on the President’s Lawn, State Equestrian Centre, and recognised outstanding contributions in various categories, including Young Coach of the Year, Volunteer of the Year, and Best Achievement by Riders across different age groups.

We honoured the dedication and hard work of our community, highlighting the spirit and camaraderie that defines Pony Club WA.

These highlights underscore the vibrant and dynamic activities of Pony Club WA in 2024, reflecting our commitment to excellence and community engagement.

As we reflect on 2024, it is evident that our Pony Club community has demonstrated incredible resilience and a steadfast commitment to equestrian sports. We have faced challenges, celebrated triumphs, and strengthened our connections as a community.

Through initiatives like these, Healthway's support has had a lasting impact on Pony Club WA members, fostering a culture of health and well-being within our equestrian community. We look forward to continuing this valuable partnership in the years ahead.

MISSION

The State Coaching Panel is responsible for the policy and direction of Coaching, subject to the approval of the Board. The Panel is also responsible for the assessment of Coaches, the issuing of proficiency certificates, organisation of Schools for potential Coaches, arranging for assessment of Coaches, the inspection of potential new Club's facilities, and all other matters that may be relevant to Coaching for members of the Association.

LEADERSHIP

The Panel has shared the role of Chairperson in 2024, spreading the load of this role. The SCP is fortunate to retain our experienced members and welcomed one new member in 2024. Coach Educators and PCANCAS Coach Assessors have travelled the State from Port Hedland to Esperance working with Regional Clubs to provide Coach and Officials training and assessment under the DLGSC Regional Services Grant.

HIGHLIGHTS

- C* & K Certificate Assessments and Schools continue to be supported by Clubs, Riders and Coach Assessors.
- Regional Services Grant - 28 Coaches have embarked on their accreditation journey, with 7 coaches finalizing their PCANCAS Coach Accreditation through this process. Given we had 38 registered PCANCAS Coaches in the Regions at the beginning of the year the future outcomes of the Regional Grants opportunity is exciting.
- Coach Education – several webinars have been held including PCANCAS Foundation and Preliminary Coaching workshops, Sports Psychology in Coaching with Mindy Simpson, and Gear Checking Updates.
- State Coaching School – continues to be a valuable resource to our Coaching members, aspiring coaches and riding centres. SCP received positive feedback from attendees and online participants.
- State Showjumping Quiz – a fun night for riders to come together and challenge their knowledge and

understanding. The Quiz provided learning, friendship and the challenge of winning a fantastic prize.

- Coach the Coaches – The SCP continued to provide funding assistance to Zones that held Coaching/Officials Development Workshops.
- New Club Port Hedland 1st Inspection completed

PARTICIPATION AND DEVELOPMENT:

Our State Gear Checkers continue to complete the bridging requirements for their PCA Accreditation Renewals. PCANCAS Coaches will also be required to complete the revised PCA requirements which will include ASC online courses and Gear checking components as part of their Accreditation Renewal.

State Sport Committee Reports

State Active Riding Committee

MISSION

As one of Pony Club's most popular disciplines, Mounted Games provides members of all ages and ability with a fun, fast-paced activity that not only teaches riding skills in an exciting and teamwork-driven environment, it also an ability to work together with other riders and a willingness to help one another. Pony Club Members compete in teams of four or five riders and have several opportunities to compete both Nationally and Internationally.

Opportunities abound for those wishing to pursue Prince Philip Mounted Games during their Pony Club career! The core values members learn in Pony Club also prepare them for other positions in the equine industry.

Riders of any skill level and ability can compete in Mounted Games and novelties, with beginners usually competing at the Lead line Walk-Trot level before moving on into the Junior and Senior advanced ranks. The levels are divided based on the ages of the riders.

Mounted Games was originally the idea of His Royal Highness, the late Prince Philip, as a way to encourage enthusiasm, participation, and training in younger riders without the need of expensive ponies or gear. A natural draw to all levels of riding abilities, Games provide a fun sport that teaches the basic natural aids, physical coordination, self-confidence, and teamwork skills. It also encourages sportsmanship and the proper care of their mounts in all riders.

They require a high degree of athletic ability, good riding skills, hand-to-eye coordination, determination, perseverance, and a competitive spirit.

Riders develop remarkable skills in the areas of timing, sense of space, speed and direction, coordination, agility and horsemanship. They also laugh a lot, which is the only way to deal with mistakes when anyone makes one.

LEADERSHIP

The AR committee ran selections in 2024 for the PPMG high performance squad State team and have had those training sessions open for all other up and coming PPMG riders as well as any parents and supporters wishing to become PPMG coaches with Sean Corbin mentoring at training days and competitions.

We are very luckily have two of our Active Riding committee members that have all but finished their level 1 Coaching accreditation. Jaqui Van-Rensberg and Jaz Anderson will no doubt make awesome level 1 coaches and will definitely be huge assets to the WA Pony Club scene.

ONGOING VISION

2025 is looking to be as fast paced as what 2024 was due to Nationals being again in Victoria with riders having to take their own horses. Nationals 2025 will be all disciplines which will be exciting times for the WA riders and supporters.

One thing we are striving to achieve in the next 12 months is to have more level one Coaches for PPMG. We have a few people that have expressed a keen interest in gaining that skill, we will very closely help and encourage those people and anyone else that is interested in doing this certificate.

We are looking into restructuring the way we run the state championships. There have been many ideas thrown around the table at the Active Riding Committee meetings as we are all striving to get more riders interested and involved in the sport. One idea is to change the plan from PPMG half days both days with runoffs on the Saturday morning and Championships on the Sunday afternoon to possibly all PPMG on one day and Novelties, Handy Pony and an Active Riding Challenge also run on one day we are trying to get more riders to have a go at the Novelties that are not confident in doing the faster paced PPMG.

We have also looked into opening up the age group for the Active Riding Challenge so that younger riders can also do the faster option instead of Handy Pony which is mostly aimed at the younger rider in gaining new skills and having fun with their pony.

State Dressage Committee

MISSION

The Dressage Committee is responsible for supporting and developing young riders by encouraging and giving them opportunities to ride at their highest level. Our intention is to grow the number of young people involved in Dressage by creating development opportunities for young dressage riders, supporting Pony Clubs who host dressage events and providing an opportunity to ride at State Championships levels. We also aim to attract, train, and retain dressage officials.

LEADERSHIP

The committee has brought with its valuable knowledge and skills, which has culminated in a successful year for the sport. The committee has utilised rider feedback from previous state championships to further to encourage participation and rider development and inclusion by expanding composite teams and higher-level test.

HIGHLIGHTS

We would like to take this opportunity to formally thank all the sponsors of the State Dressage Championships, 2024 did not have a naming writes sponsor however without the support of all the individual sponsors the event would not be possible. The event was highly successful with the most positive of feedback from clubs and riders. With entry numbers healthy and the committee working hard to reduce costs where possible the event was also a financial success.

The format repeat from 2023 was again well received by the community as was the inclusion of the new "Special Additional Awards" such as the best smile as per judges choice together with the best tail. The high participations levels in the decoration of the stables and cleanliness awards indicating very strong and positive culture within the community.

PARTICIPATION AND DEVELOPMENT

Training was provided to volunteers of the state championship event for the "Scribing" function, via Zoom meetings with trained volunteers utilised at the 2024 event there was an exceptional result in the smooth running of all the rings.

Dressage Judge training was undertaken in early 2024 in collaboration with Wendy Barker, EA Judge Educator, for volunteers and G level judges to grow the capacity of suitably qualified judges for grass roots Pony Clubs dressage events. The course consisted of three Zoom sessions covering theory, an open book rule test covering EA and PC specific rules, and finally practical evaluation which comprised shadow judging at Wallangarra RPC, a range of riders and horses.

The event was then held in November at Serpentine Horse and Pony Club. The eventing committee and the Serpentine committee worked hard together to put on an event for riders from all over the State. Due to the date change we were unfortunate with the weather getting quite hot over the weekend. International: WA sent a strong contingent of riders to represent Australia on the International Tetrathlon Exchange with Isabelle Cox, Cambell Black, Dan Wiese and Emma Wiese giving strong performances across the three competitions in Ireland, Northern Ireland and England. Nikita Mawhirt was selected to be the National Coach and did WA proud steering the team with knowledge and professionalism. Going with them were several members of the WA tetrathlon committee who were inspired by the vibrant tetrathlon community in Ireland and the United Kingdom to bring some ideas back with them. These include bringing back the timed swim to encourage participation by making the swim less intimidating and returning to cross country to enhance the enjoyment and challenge of the ride phase of tetrathlon. Everyone that went overseas had an excellent time barring sickness and represented Australia and Pony Club WA admirably.

State: The 2024 State Tetrathlon Championships at the State Equestrian Centre saw lower participation numbers with 57 competitors. However, the calibre of competitors was extremely high with 10 competitors having a total score in excess of 4000, a really positive sign as the sport builds towards Nationals in 2025.

Club: In a difficult year for hosting competition due to the extreme heat several tetrathlons at the start of the year had to be cancelled and despite the best efforts of Serpentine and Wallangarra they were unable to find any suitable replacement weekends in the packed pony club calendar. The calendar included two Club Tetrathlons as well as the State Championships. These were held at Mortlock and Busselton, it was great to have Busselton run their first tetrathlons this year. Both events were a great success and we hope Busselton will continue to run tetrathlons into the future.

PARTICIPATION AND DEVELOPMENT

This year has seen the development of the National Tetrathlon Technical Delegate Training Program and Pathway. WA has been the leader in this process through Sarah Wiese on the National Tetrathlon Committee.

Our zone covers 3 clubs, Bonnie Rock, Kellerberrin and Bruce Rock and we aim to work together to support and mentor each club.

Our zone's main event is the Eastern Zone One Day event, hosted by Kellerberrin Pony Club who has the lions share of the work in providing the venue and preparing the cross country course, however we work in with all clubs in that Bonnie Rock organises the showjumping and Bruce Rock the Dressage, and it is always a group effort to coordinate. Like most events we attended throughout the year, numbers were low and we are all looking for ways to continue to run these events at an affordable price.

We had 2 well attended zone camps, one at Kellerberrin and the second at Bonnie Rock, these camps are always huge highlights for our zone with two days of great coaching, and fun and friendship for our riders young and old. Our zone had 6 riders attain their C certificate and were lucky to have some of them assessed at Bonnie Rock by a member of the state coaching panel. We had one coach pass her preliminary coaching certificate, with several others working towards completion this year. We had many riders win and place well on the state eventing leaderboard.

State Eventing was very well attended by members of our zone, despite the date being late November, and we had a complete team in the 80cm Championship class which hasn't happened for a very long time. When we loaded our horses for the 6 hour trek home however, it was 38 degrees and that is definitely not ideal when they have just competed in both jumping phases of an event- definitely something that I would like to see changed going forward. Zone members also successfully competed in the State tetrathlon, so great to see our little clubs competing and doing so well at a state level.

It is really interesting times for our pony clubs with social licence playing a large part in a lot of new regulations that are being implemented nationally, creating more expense and potentially making our smaller regional events unviable to run, but I really hope we can continue to bring experiences and passion for the sport to all our riders, coaches and parents.

**NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR
ENDED 31 DECEMBER 2024**

Note 1. Statement of Material Accounting Policies

These financial statements are a special purpose financial report prepared in order to satisfy the financial reporting requirements of Pony Club Western Australia Incorporated (the "Association"), and to satisfy the Associations Incorporations Act of 2015. The Board has determined that the Association is not a reporting entity and therefore there is no requirement to apply Accounting Standard and other mandatory professional reporting requirements in the preparation and presentation of these financial statements.

The financial statements have been prepared in accordance with the requirements of the Associations Incorporation Act 2015 and the following Australian Accounting Standards:

AASB 101 - Presentation of Financial Statements
AASB 107 - Statement of Cash Flows
AASB 108 - Accounting Policies, Changes in accounting Estimates and Errors
AASB 110 - Events After the Reporting Period
AASB 1054 - Australian Additional Disclosures
AASB 16 - Leases

No other applicable Accounting Standards or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial statements have been prepared on an accruals basis and is based on historic costs and does not take into account changing money values, or except where stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Inventories

The Association opted not to capitalise inventories. Consequently, all inventories are expensed in the statement of profit or loss and other comprehensive income in the financial year they are incurred.

(b) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment are measured at cost less depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably.

1 Statement of Material Accounting Policies (Continued)

(c) Property, Plant and Equipment (Continued)

Depreciation

The depreciable amount of all fixed assets including building and capitalised leased assets, but excluding freehold land, is depreciated on a straight-line basis over their useful lives to the Association commencing from the time the asset is held ready for use. Leased assets and leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the assets.

The depreciation rates used for each class of depreciable assets are:

<i>Class of Fixed Asset</i>	<i>Depreciation Rate</i>
Computer software & hardware	40% - 100%
Plant and equipment	10% - 100%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting period date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

(c) Impairment of Assets

At each reporting date, the Association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of profit or loss and other comprehensive income.

1 Statement of Material Accounting Policies (Continued)

(d) Employee Benefits

Short-term employee benefits

Short-term employee benefits are benefits, other than termination benefits, that are expected to be settled wholly within twelve (12) months after the end of the period in which the employees render the related service. Examples of such benefits include wages and salaries, non-monetary benefits and accumulating sick leave. Short-term employee benefits are measured at the undiscounted amounts expected to be paid when the liabilities are settled.

Other long-term employee benefits

The Association's liabilities for annual leave and long service leave are included in other long-term benefits as they are not expected to be settled wholly within twelve (12) months after the end of the period in which the employees render the related service. They are measured at the present value of the expected future payments to be made to employees.

The expected future payments incorporate anticipated future wage and salary levels, experience of employee departures and periods of service, and are discounted at rates determined by reference to market yields at the end of the reporting period on high quality corporate bonds that have maturity dates that approximate the timing of the estimated future cash outflows.

Any re-measurements arising from experience adjustments and changes in assumptions are recognised in profit or loss in the periods in which the changes occur.

The Association presents employee benefit obligations as current liabilities in the statement of financial position if the Association does not have an unconditional right to defer settlement for at least twelve (12) months after the reporting period, irrespective of when the actual settlement is expected to take place.

(e) Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(f) Cash and Cash Equivalents

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

1 Statement of Material Accounting Policies (Continued)

(g) Trade and Other Receivable

Trade and other receivables include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(h) Revenue

Revenue arises mainly from fees received from members and revenue from sporting events. To determine whether to recognise revenue, the Association follows a 5-step process:

1. Identifying the contract with a customer
2. Identifying the performance obligations
3. Determining the transaction price
4. Allocating the transaction price to the performance obligations
5. Recognising revenue when/as performance obligation(s) are satisfied.

The total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time, when (or as) the Association satisfies performance obligations by transferring the promised goods or services to its members. The Association recognises contract liabilities for consideration received in respect of unsatisfied performance obligations and reports these amounts as other liabilities in the statement of financial position. Similarly, if the Association satisfies a performance obligation before it receives the consideration, the Association recognises either a contract asset or a receivable in its statement of financial position, depending on whether something other than the passage of time is required before the consideration is due.

Interest revenue is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount.

All revenue is stated net of the amount of Goods and Services Tax (GST).

(i) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

1 Statement of Material Accounting Policies (Continued)

(j) Leases

The Association considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition the Association assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Association
- the Association has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract
- the Association has the right to direct the use of the identified asset throughout the period of use. The Association assess whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use

Measurement and recognition of leases as a lessee

At lease commencement date, the Association recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Association, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Association depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Association also assesses the right-of-use asset for impairment when such indicators exist.

At the commencement date, the Association measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Association's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments. When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset or profit and loss if the right-of-use asset is already reduced to zero.

The Association has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these are recognised as an expense in profit or loss on a straight-line basis over the lease term.

Concessionary Leases

For leases that have significantly below-market terms and conditions principally to enable the Association to further its objectives (commonly known as peppercorn/concessionary leases), the Association measures the right of use assets at cost on initial recognition.

(k) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST. Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows
